# DGS Receives \$40,500 Bequest from Morrison Estate



The Dallas Genealogical Society has received a bequest from the Estate of C. Maxine Morrison in the amount of \$40,500. C. Maxine Morrison was born June 15, 1917 in Cloverdale, Indiana to Louis Franklin Morrison and Nora Elizabeth Cunningham. She graduated from Indiana State University and worked for the FDIC, GAO and Post Office Department in Washington, D.C., Asheville, NC, and Dallas, TX. After early retirement in 1971 she traveled to Australia and New Zealand, China, Europe, and Japan, as well as to many places in the U.S., Canada, and Mexico.

A member of DGS for almost 20 years, Maxine did genealogical research, including visits to courthouses, libraries, and cemeteries in Indiana, North Carolina, Tennessee, and Virginia.

She died January 11, 2011, and was buried in Cloverdale, Indiana.

A check in the amount of the bequest was received from Maxine Shaw, Executrix, also a former DGS member. The DGS Board is considering how best to use this bequest, and will announce their decision at a future General meeting of the Society when Ms. Shaw can be present.

He harbored a deep distrust of government authority his entire life, and may have felt the detailed questions on this census were too personal.)

## Texas State Genealogical Society announces plan to publish Volume 3 of Texas First Families Lineages

This new volume will include all applications approved from #5279 through the ones approved through June 30, 2012.

Applicants do not have to be members of TSGS nor residents of Texas. Applications can be completed online and printed or complete instructions can be downloaded from the TSGS website.

Applicants must prove direct or collateral descent from an ancestor who settled in Texas before February 19, 1846, the day of the ceremony on which the Republic of Texas turned the government over to the State of Texas. The applicant must prove descent from the ancestor by an official record for each generation and each date and event that is listed on the application such as births, deaths and marriages. Proof that the ancestor was in Texas by this date should also be provided by an official document. A nonrefundable fee of \$30 must accompany each application. TSGS is planning to publish Vol. 3 of the Texas First Families application lineages by November of 2012. The deadline for submitting an application to be included in Vol. 3 is June 30, 2012. The certificate program will remain open and applications can be approved after this date but the lineages will not be included in Vol. 3 if not received by June 30, 2012.

> Two volumes of Texas First Families application lineages have been published. Vol. 1 contains lineages from applications 1 through 2400, 431 pp, \$35.00 Vol. 2 contains lineages from applications 2401 through 5278, 540 pp, \$35.00 Shipping is \$6.50 per book. Bundle order for Vol. 1 and 2, \$60.00

All members of SRT, DRT and CRT and their descendants as well as siblings and other direct line relatives are eligible for this certificate but must submit a complete application with documented proof of descendancy. These certificates are nice for family members who may not wish to belong to the lineage group and pay dues but would like a certificate recognizing their ancestor.

All applications and supporting documentation will become the property of Texas State Genealogical Society. All previously approved applications are available for research at the East Texas Research Center located in Steen Library at Stephen F. Austin State University in Nacogdoches. Copies from any of those files are allowed.
