- State Property Laws
 - ✓ Common Law: Based on English laws, a married woman (feme covert) ceased to exist as an individual with legal property rights. Property she owned or later inherited belonged to her husband. Upon his death, she received one-third of his property for her lifetime use (dower rights). She could leave a will only with his approval.
 - ✓ Community Property Law: A married woman had the same property rights as her husband. Property she owned before marriage or later inherited remained hers. She often left a will.
